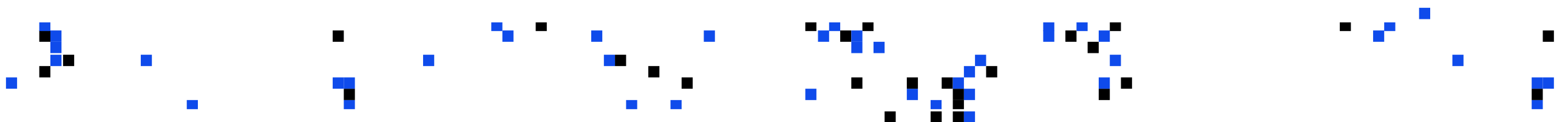

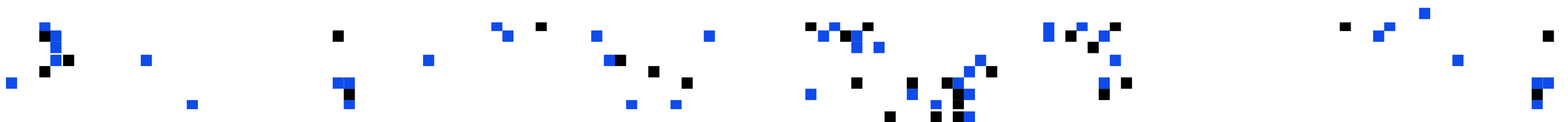
A Story of Institutional Change

 - Public Libraries, Public Librarians and trustworthiness in the community



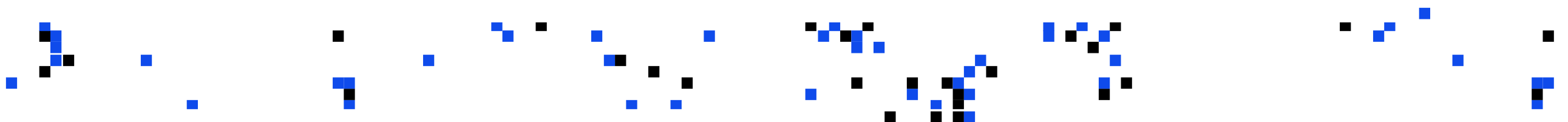
Our Question

Given the changes in society and in the workplace for local government employees, is a new regime of truth emerging?



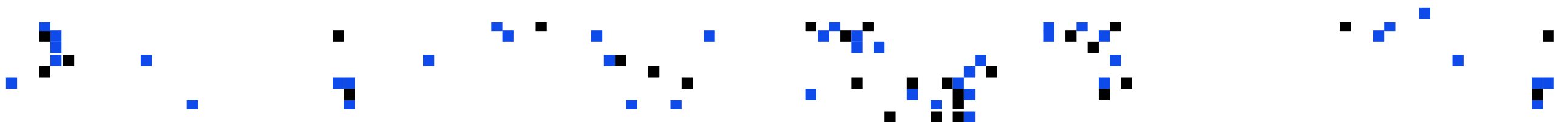
The Workplace

- Local Government and its Employees
 - More highly educated than workforce in general
 - Tend to stay in the job longer
 - Tend to be older
- ‘Corporate Librarians’
 - Experienced librarians
 - Specific responsibility to work with council staff
 - Numbers declining



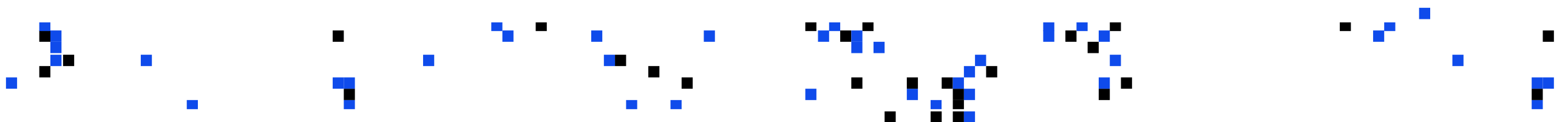
The Study

- Interested in their specialist roles and notions of civil commitment and contribution to democratic processes
- Explored what services specialist public librarians offer to local government employees
- Explored where else in the community responsibility for a well-informed community might lie
- Asked what do specialist public librarians wish for to support the development of democratic processes in their community?



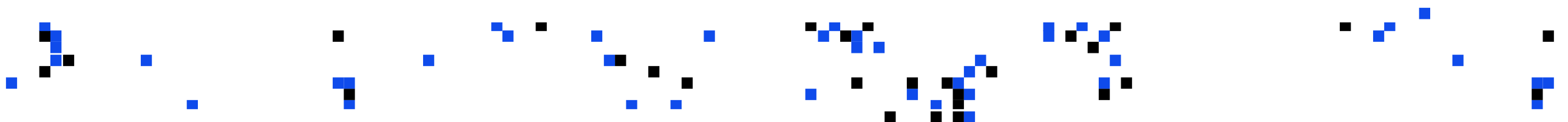
‘in the past but not so much now’

- Changes in the workplace
 - Introduction of technology
 - Council decisions on funding specialist resources
 - Stronger skills in information literacy of council staff
 - Pace of decision-making
 - Responsibilities for information provision in the community
 - Less support for public libraries as having a role in the maintenance of a democratic society
 - Shift in understanding of ethical relationship with elected representatives.



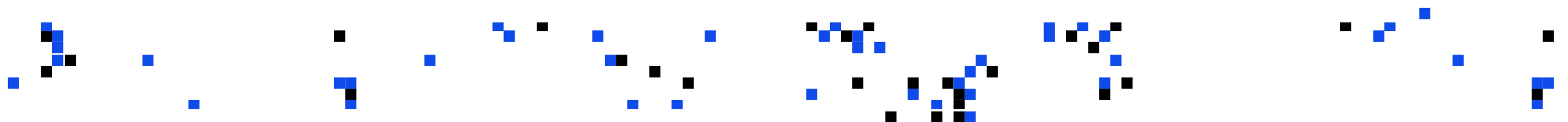
What they told us

- We've always had internet access ... , but not everyone had ... now council has [arranged access to specialised resources for everyone] so [the searching] still exists in council but it's not the corporate librarian's realm.
- It's very much at arms length from councillors ... well the code of conduct – we can't talk to them
- The people setting the policy at the local level just need to be informed with the actual facts. [Social media] well it's not quality is it?
- A lot of the information has been politicised ... that politician going “Yeah, I went out in a boat and looked” isn't the same as scientific explorations”.
- It's not like it's a new thing that libraries are doing
- I suppose in lots of ways things haven't changed



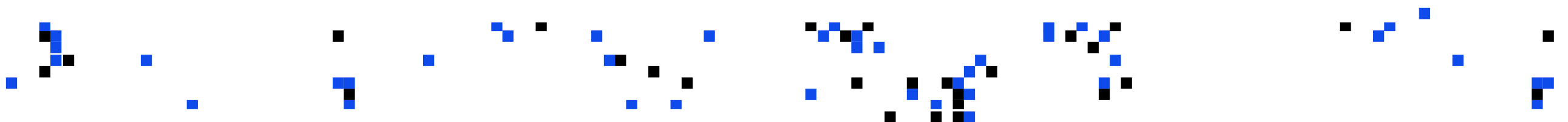
The librarians' dilemmas

- Librarians:
 - no longer being the gatekeepers to authoritative information
 - maintaining a clear focus on a set of tasks agreed by the group of corporate librarians: including workplace induction session
 - developing relationships with elected representatives in support of democratic processes



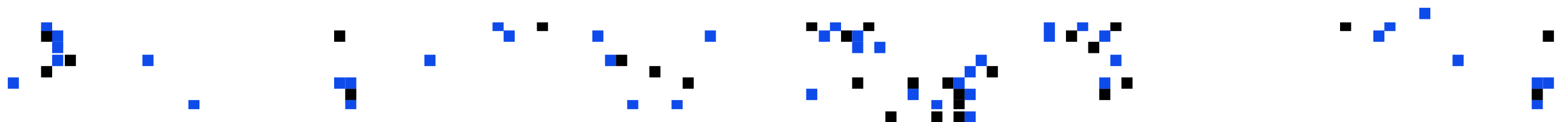
The dilemma with information literacy

- Developing individuals who are information literate by supporting local government employees in the employees' context
- Creating a workplace culture accepting the principles of quality in information and information resources



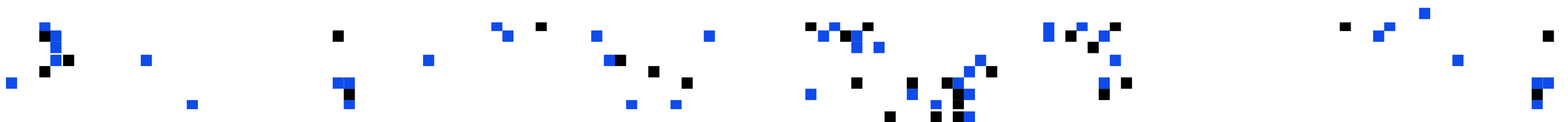
What they would like in their work place

- Free and unimpeded access to information
- Increased funding to broaden base of resources
- Dispersing the hive mind
- Stronger ties with local university libraries to enhance information literacy
- Better understanding for elected representatives and citizens of workings of democracy at a local level



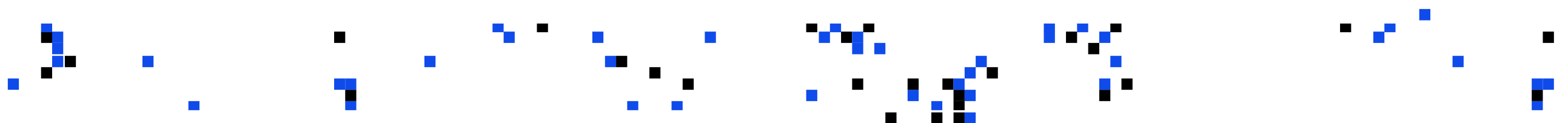
Regime of Truth for these Librarians

- Some fundamental changes in the workplace
- Some fundamental changes to access to information in society
- Some weakening of position of the public library in the democratic processes
- BUT **Some things remain the same**



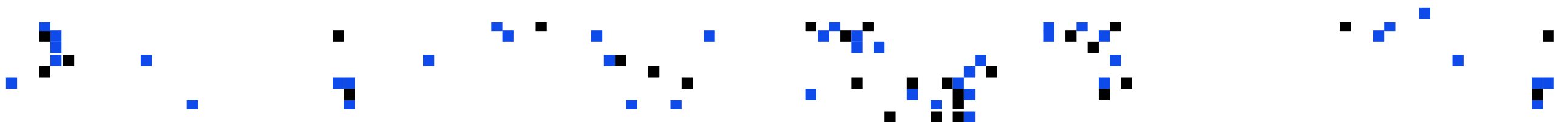
Their Unchanged Regime of Truth

- Professional principles, knowledge and skills of these public librarians;
- Acceptance of ways to establish quality of information



Civil Commitment for the Future

- Even though they have had to give up the role of gatekeeper to information for other employees ...
- These specialist librarians believe they can:
 - Articulate for their employers and for other employees in local government:
 - Principles and criteria for judging the trustworthiness of information
 - Differences between opinion, experience and evidence
 - Advocate for adoption of these principles (perhaps)
 - Collaborate with others in the community to consolidate the new regime which values diversity of thought based on information coming from a variety of sources.
